#### TELEVISION REPAIR CLASS - OPEN TO ALL

A few people have inquired about having a class in television repair. West Valley College is offering such a class this fall. It's called Electronics 57, Commercial Repair. The WVC catalogue gives the following description of the class:

"Troubleshooting techniques and methods of repair of television receivers, radios, phonographs and other electronic devices found in home and industry."

This fall the class is being offered on Monday and Wednesday nights, from 7 to 10 p.m. (PLEASE NOTE: That is Monday AND Wednesday, not Monday OR Wednesday.)

Fall semester at WVC runs from September 11 to January 24. The deadline for applications for evening students is August 10th. Please also note that you must apply IN PERSON at the Admissions Office at the Saratoga Campus.

The fee for enrolling in evening classes at West Valley is \$6.25, whether you take one, two, or forty classes. ATARI will pick up the tab for that \$6.25 fee if you take Electronics 57, and then you can take another class or two for free.

## EDITORIAL

Just wondering why the company can spend anywhere between \$500 and \$1000 per month for company cars. (I know that is a wide spread, but as you know, facts are very difficult to obtain around here.) Now, the thing that I cannot understand is why we can't spend another \$125 per month to lease a truck for manufacturing. This way we could get our parts and supplies when we need them.

A certain case in mind: About two weeks ago we ran out of "D" rings for the television mount strap. Our present truck was and is not capable of constantly making 100-mile round trips. Frankly, it's not capable, nor is it SAFE, for much of anything at all. Consequently the "D" rings were delivered three days later.

If I had to do it my way, I would spend my money making sure that my product was going out the back door, rather than spending it on fancy cars and "experts". Company expenses are especially hard to understand in light of the fact that the people working in Final Assembly are not really making enough money to exist in this world today. It is your responsibility to support the people who put the butter on your bread - not to fight them every inch of the way. The people are getting tired of trying to do the job asked of them, only to find that they don't have the parts and/or the tools to do the job correctly.

I think the priorities of this company should be examined and reorganized. If the assorted V.P.'s and the other one and two-man departments would really do their own job of supporting manufacturing, instead of wandering around the production area making constant changes in procedure on the spot (and without proper documentation), I think it would relieve some of the friction and confusion.

I say, if you give someone a job, by God let him do it. Then, if he can't handle it, you know where the problem is. As the system exists now, you cannot honestly say whether or not someone is doing his job - with everyone else in there trying to do it for him.

#### PROPOSED ORGANIZATION

#### ATARI EMPLOYEE COUNCIL

#### 1. Structure

- A. One vote for each representative from each section
  - 1. One employee from each department
  - 2. Four representatives from the group of lead people
  - 3. Two representatives from the group of supervisors
- B. Two votes TOTAL from four areas
  - 1. Personnel
  - 2. Accounting
  - 3. Engineering
  - 4. Purchasing

# II. Elections and Impeachments

- A. Representatives are elected from one-third of the departments every month.

  Departments are picked in alphabetical order. Representatives will serve three-month terms.
- B. Two lead people are replaced every two months. Each lead person will serve a four-month term.
- C. Supervisors will be chosen among themselves as required.
- D. Elections will not be required for the representatives from Personnel, Accounting, Engineering, and Purchasing.
- E. Impeachment grounds
  - 1. Absence totaling 30% of the meetings
  - 2. Two-thirds vote of the department involved
- F. The impeached representative is replaced by the person having the second highest number of votes in the last election (if still in the employ of Atari)

#### III. Powers

- A. No one shall be fired against his/her will without the explicit consent of two-thirds of the council.
- B. No one shall be transferred out of their department against their will without the explicit consent of two-thirds of the council
- C. No company policies directly affecting the employee environment shall be passed without two-thirds consent of the council
- D. These powers of the council cannot be expanded, limited, or changed in any way without the following
  - 1. Two-thirds vote of the council
  - 2. Two-thirds vote of the plant

# IV. Violations

- A. Violations of council policies shall be treated as the council determines
- B. Any action policies determined by the council that violates previous policies still in effect are void

# V. Committees

- A. The council has the power to form any committee for research, fund raising, etc., as it sees fit
- B. Committees act only as advisory bodies and have no other authority
- VI. Interaction with the office of the President
  - A. The President of the company has veto power over any policy, action, or amendment passed by the council.
  - B. The council, by three-fourths majority, may override a presidential veto after an appropriate discussion between the council and the President.

# VII. Immunity of the council members

- A. Council representatives are free from any punitive action involving their performance of a council-approved function, vote choice, council attendance, or anything said during attendance of a council meeting.
- .B. No council member or perspective council member shall be blocked or in any way interfered with while running for office.
- C. No one shall in any way interfere with a council election

#### VIII. Council officers

- A. Council shall elect a chairman and a secretary once every three months, based on a two-thirds majority
- B. Council officers may be impeached at any time by a two-thirds majority
- C. The chairman shall have no special authority except to keep order
- D. The secretary shall have no special suthority except to document council actions and vote tally, and to record each representative's vote if a roll call vote is called for by any member
- E. General election results will be counted by the secretary in the presence of the council, and will be seen or tampered with by no one beforehand

#### I. Roll taken

- II. Continuation of review of proposed organizational plan
  - A. Impeachment
    - 1. Absence
      - a. Excessive absence of representative from Council meetings will be reviewed by the Council and with 2/3 vote the Council will take appropriate action.
      - b. Department heads may not refuse to allow a representative to attend a Council meeting. Attendance will take precedence over normal business.
    - 2. Dismissal
      - a. The Council, with 2/3 vote, may dismiss any representative with due cause
      - b. The representative has the right of appeal
      - c. The impeached representative's alternate will replace him.
  - B. Powers of the Council
    - 1. Firing & Transfer
      - a. The Council assumes full power, with Nolan Bushnell having the final say
      - b. The employee in question must request a hearing
      - c. The representative and the alternate will make a thorough investigation and present it to the Council

- d. The employee and his supervisor must be present
- e. The employee in question may get another person to represent him
- f. Appropriate records must be open to investigation so facts may be gathered
- g. The Council will come to a conclusion about the case that meeting
- h. If a supervisor or employee discriminates against a representative who is presenting a case before the Council, the Council will take appropriate action.
- i. Any grievances should be taken to the appropriate representative.

#### III. Party Fund

- A. The employee party fund of \$270.04 has been turned over to the Council.
  - 1. It will be deposited into a savings account
  - 2. Every three months the money from the vending machines will be deposited.
  - Money received from the sale of scrap materials will be deposited into this account.
- B. Suzie Stevens has been elected Treasurer

#### IV. Scrap materials

If you are an omelet lover, the Broken Egg is your place in Los Gatos. Aside from the omelets on the menu, you can create your own combinations, for a moderate extra charge. Most every omelet they have is good, however, you might find yourself tiring of the sauced omelets before too long. Then, try another - filled or mixed.

Aside from their omelets, they have a great fresh fruit bowl, and their fruit shakes are fantastic.

One extra nice feature is that they are open seven days a week, and also their hours are from 7 a.m. until midnight. This provides a nice alternative to the Sambo's route for late eaters.

The decor is simple and pleasant. The waitresses are not really the friendliest people in town, but they do get the job done. The service is not super-fast, but you should be able to be in and out within the alloted lunch period.

All in all, it's not as good as Sir Toby's - We give it three stars. But it sure is a lot better than the garbage truck.

# CARROT CAKE

3 cups flour
2 cups sugar
4 eggs
2 tsp. baking soda
2 tsp. baking powder
2 tsp. cinnamon
1-1/3 cups salad oil
4 eggs
2 cups finely shredded carrot (about 5 lg. carrots)
1 cup cruched pineapple with syrup
2 tsp. cinnamon
2 tsp. vanilla
1 cup puffed raisins

Sift dry ingredients together. Add remaining items. Mix until blended. Beat for two minutes with an electric mixer - or by hand until you begin to wonder if your arm is going to fall off. Bake in a greased and floured 13x9x2" pan at 350 degrees for approximately 50 minutes.

## CREAM CHEESE FROSTING

6 ounces cream cheese - softened

1 TB. butter

1 tsp. vanilla

 $2\frac{1}{2}$  to 4 cups powdered sugar (to taste)

1 cup chopped nuts.

Combine cream cheese, butter and vanilla. Beat until fluffy. Gradually beat in the sugar. (The original recipe called for 4 cups of powdered sugar, but that makes the frosting terrifically sweet.  $2\frac{1}{2}$  or 3 cups is plenty.) Mix in  $\frac{1}{2}$  cup of the nuts into the frosting, and sprinkle the other  $\frac{1}{2}$  cup on top of the frosted cake.

NOTE: Rumor has it that this cake is the way to the heart of Paul McCullough.

#### JELLO CAKE

- l package Cake Mix l package Dream Whip
- 4 eggs
- 1 cup Cold Water

Mix all ingredients together at high speed using portable mixer for approximately 8 minutes. Bake cake in sheet pan. 350° for 30-35 minutes. Remove cake from oven. and use 1 box jello, 3/4 cup hot water. Stir until jello disolves. Add 1 cup ice cubes + water. When cake has cooled, use swizel stick to make holes in cake, drizzel jello over cake. Save 4 cup jello and mix with one package cool whip plus 3/4 cup cold water for icing.

To make cake really scrumptous, use Lime jello and substitute 4 cup Creme de menthe in place of water.

#### **MEDITATION**

(Exerpts from <u>KUNG FU MEDITATIONS</u> by Ellen Kei Hua, Published June, 1973, by The Farout Press)

The aim of meditation is to achieve peace of mind and quiet spirit.

Meditation is not generally connected with any physical exercise or activity but meditation can help you in your studies by putting your mind in a receptive state.

#### HOW TO BEGIN MEDITATION

To begin meditation, you must first find a quiet place where you can block out as much noise as possible. An outdoor area, for instance, if you have access to the country. Or, if your choices are limited, choose the quietest place you can at home.

The lotus position is not recommended for beginners as your limbs would feel the strain and perhaps deter you from your meditation. Start with a cross-legged Indian position with your back straight and your hands resting lightly palm up or palm down on your knees. You should be in a level area: if you are outdoors, the grass or dirt will make a comfortable blanket; if you are indoors you should sit on the floor, on a rug or mat.

When beginning meditation exercises, you must try to rid your mind of any thoughts and concentrate solely on the particular meditation aid you have chosen. At first you may find this difficult, as your mind will start to wander into a multitude of worldly thoughts such as, ""What am I going to have for dinner?", "I wonder if it is going to rain", "Did I lock my car?" Do not feel frustrated during your first attempts at meditation, as this is contrary to the practice itself. Each time you find yourself wandering from your meditation, note where your thoughts are going and return to the practice itself.

Read the meditation exercise. Repeat the words to yourself slowly several times. (You should be in the meditation position.) Close your eyes and meditate upon the meaning of the words. Try to meditate and remain in that state for several minutes at the beginning, increasing the time span as you feel you are able. You will find that the more you meditate, the easier it becomes.

You have no doubt heard of enlightened Eastern masters who spend most of their lives in caves in deep meditation without uttering a word to anyone. This way of being is not available to nor perhaps desirable for most of you and it takes many years to reach this high state of meditation. You must not feel that you will receive instant illumination by meditation, but daily meditation practice can help anyone to achieve peace of mind. This in turn will aid you in ridding yourself of negative thoughts and the frustration of daily life, because things cease to be frustrating and annoying when your mind

is peaceful. The aim of any meditational practice is to help the student gain peace of mind and self-knowledge and whitchever method helps the individual to attain that goal is right for that person.

Some beginning and effective meditation practices are: concentration on a single sound, such as the ring of a bell, or enunciation of a sound such as OM (or "aum": the mystic equivalent for the name of God, also symbolizing the triple constitution of the cosmos; the absolute, the relative, and the relation between them. It has been adopted by modern occultists to denote absolute goodness and spiritual truth.) OM can either be pronounced aloud or thought silently and is universally used in meditation practice.

When employing the sound of a bell, ring the bell once and meditate on the sound it makes, following the sound into infinity. When using OM, think or say the word to yourself, drawing out the syllable, and keeps other thoughts on this sound. You can meditate on anything that wind, the song of a bird. The idea of these aids is that after awhile wind, the song of a bird. The idea of these aids is that after awhile wild, not need the sound but will remain in a peaceful no-mind state.

buiM-oN

The concept of no-mind is difficult for a Westerner to comprehend because we have been conditioned to think that we must always have thoughts in our minds. No-mind means that you are free of worldly with the Universal Consciousness. No-mind is universally accepted throughout the East and many individuals - businessmen, professionals and working people - spend time daily in meditational no-mind practice.

The Kung Fu meditations contain many references to the "Tao", (pronounced Dow). The "tao" means the Way. All meditation and spiritual exercise leads to the Way. The Way does not refer to peace only during meditational practice; it applies to peace in your general outlook when dealing with daily life. When you have found the Way you can find peace in all things. Violence and hostility shall disappear from your being, to be replaced by love for all things.

The teachings of the tao are to be found in the Tao Te Ching by Lao Tze (an older Chinese contemporary of Confucious) and in the book of Chuang-Tse, as well as the works of many lesser known sages.

For those of you unfamiliar with Chinese sayings and philosophy, some of them may seem difficult to understand; so do not try to understand them; meditate on them. Much of the vagueness in the Chinese phrases is due to the difficulty of turning the vagueness of Chinese literature into the definiteness of English thought. At best, language can never of others. And in the Chinese language, one character can stand for several different things and can be used interchangeably as a noun, verb and adjective. Therefore, several different meanings can be inferred from each phrase and it is left to the translator's discretion to red from each phrase and it is left to the translator's discretion to convey the value and meaning of the phrase.

So, read the thoughts and meditate upon them. Read them over and over and the words will flow effortlessly through your head. The meanings will be unveiled to you when you are ready to receive them; probably when you least expect it.

The Way is to find meditation and peace in everything you do, be it mowing the lawn, playing an instrument, washing the dishes, looking at the stars, building a house. As long as you find yourself doing that particular thing, you might as well enjoy it. Do not think of what you <u>could</u> be doing. Think of what you <u>are</u> doing and find peace within yourself. This is the aim of all meditational practice.
